ORDER

National Institute of Speech & Hearing (NISH), a society set up with the support of the Government of Kerala, has been conducting four courses out of which three are Bachelor level and one is a master level course affiliated to the University of Kerala as detailed below:

- a) Bachelor of Computer Science (Hearing Impaired)
- b) Bachelor of Fine Arts (Hearing Impaired)
- c) Bachelor of Audiology and Speech Language Pathology (BASLP) &
- d) Master of Audiology and Speech Language Pathology (MASLP)

2. The above courses come outside the framework of Kerala University of Health Sciences except for the BASLP and MASLP programs. Bachelor of Audiology and Speech Language Pathology (BASLP) and Master of Audiology and Speech Language Pathology (MASLP) programs, approved by the Rehabilitation Council of India (RCI) are affiliated to the University of Kerala as self-financing courses since 2002 and 2006 respectively. As per Clause 50 of Kerala University of Health Sciences Act, 2010, the National Institute of Speech and Hearing has to obtain the affiliation of the Kerala University of Health Sciences, Thrissur for Bachelor in Audiology and Speech Language Pathology (BASLP) and Master in Audiology and Speech Language Pathology (MASLP) courses. As per the order read as second paper above, Government granted permission to the institution to continue affiliation to the University of Kerala for all courses including Bachelor in Audiology and Speech Language Pathology (BASLP) and Master in Audiology and Speech Language Pathology (MASLP) courses.

3. As per letter read as third paper above, the Registrar, University of Kerala informed NISH that the affiliation with University of Kerala ends with the academic year 2017-18 and directed it to transfer these courses to Kerala University of Health

[PTO]

Sciences. As per letter read as fourth paper above, the Executive Director, National Institute of Speech and Hearing, Thiruvananthapuram has requested for Government order disaffiliating BASLP & MASLP courses from University of Kerala and affiliating these courses to Kerala University of Health Sciences.

4. Government have examined the matter in detail and are pleased to grant No Objection Certificate to the National Institute of Speech & Hearing, Thiruvananthapuram to conduct BASLP & MASLP courses under Kerala University of Health Sciences, from the academic year 2018-19 onwards, with the following permissions:

- to disaffiliate its BASLP and MASLP courses from the University of Kerala, and get them affiliated to Kerala University of Health Sciences;
- continuation of affiliation of the degree programmes for the hearing impaired [Bachelor of Computer Science (Hearing Impaired) & Bachelor of Fine Arts (Hearing Impaired)] at NISH with the University of Kerala;
- operation of all the above courses, affiliated to the University of Kerala and the Kerala University of Health Sciences, from the same campus, as a special case, considering that NISH has only one campus, located at Akkulam, Thiruvananthapuram.


